I am in full recognition and appreciation of the dangers and hazards inherent in the martial arts, to which I may be exposed during my study of the Martial Arts and/or Brazilian Jiu-Jitsu.

I further understand and have had explained to me that along with the possibility of personal injury, injury to property is also possible such as, but not limited to possible loss of wages and the ability to earn such wages.

With full knowledge of these dangers, both myself and to my current and future property, and after having these dangers explained to myself and/or my Legal Guardian, I certify and declare that I will release and forever hold free and discharge from any liability, Romolo Barros, Brazilian Freestyle Jiu-Jitsu, ~~their~~ agents, employees and representatives, acting officially or otherwise, of and from all claims, demands, rights, and causes of action of any nature whatsoever which I may have or which may hereafter accrue to me, arising from and by reason of any and all bodily or personal injury, damage to property or other loss, and any consequence thereof, whether known or unknown, seen or unforeseen, resulting from my participation in the Martial Arts and/or "Brazilian Jiu-Jitsu" the persons and entities mentioned above.

Further, knowing and understanding these risks, nevertheless, I hereby agree to voluntarily assume all risks and responsibilities surrounding my participation in such activities and to release and hold harmless all the persons or entities mentioned above who might otherwise be liable to me for damages.
